#### Audit Exit Interview

Waiting for owner to purchase their 2" apartment meters, they are asking for blocks of 4. It looks like they are also moving ahead with the single-family homes now as well, also in groups of 4. We are working with our meter supplier to get stock ready to go out.

## **CEDS** project funding

Meeting to establish the well site and to get the process started for the bid docs as well as the contracts laid out with geo tech and engineering and get the documents drawn up so that we can then have a conversation with Mason County. Will be checking back with the county to see where our other projects are at.

#### Overton and Associates

Working with David and his team to figure out where our well site will be as well as what the path will need to be to get the property secured.

#### Romance Hill development

Nothing new here, at this point it is unlikely that anything will be done here until the property sells.

## Maintenance and Operations -

Annual report-Still working to get the annual report done, working on the setup of the vision program, it currently is not tracking things in a manner that coincides with the needed schedules. Currently much of the set up in vision is being adjusted. Once the program is set up correctly then it will be simple process going forward. Have meetings set up with the SAO help desk to guide our set up to the best possible conclusion. Current reconciliation is still going well.

Site maintenance is continuing, and field staff are working on the leaks detected in the leak assessment. Running reports on the meter reads and grabbing some of the continuous leaks as well as zero reads and working them thru each month and keeping notes on same.

There is a lot of stuff going on, well and reservoir repairs and maintenance continues, hydrant cleaning and valve exercising as well as work on mapping and system ids for hydrants and valves.
