We have been looking for another vehicle for a long time. Webb and Freeman went out and looked at used vehicles and found the price and condition of the vehicle in question to be better than anything looked at in the price point.

**Resolution 2023-03** was presented to the Board, the resolution is to surplus the District Jeep Wrangler, and to send it to Stokes Auction as soon as possible. Commissioner Satran-Loudin motioned and Commissioner Born seconded, Commissioner Born called for the vote.

## 7) Manager Update:

#### Olympic Ridge, Olympic View development

Olympic View Apartments-

All meters that have been purchased for the Apartments are installed now, we are waiting on funds for the last two meters on that side of the project. The back side has been placed on hold, Freeman will likely touch on that in his report on operations..

Olympic Ridge Homes-

Currently they are waiting for funds for the 2 additional meters for irrigation they have requested, the check for these should be here next week and will up the total for the housing development to 146 meters.

**CEDS Project Funding** 

Back up Generators for Well 4, Office and Romance Hill.

Emergency Generators expected dates are currently as follows:

All the ATS switchgear should be arriving by the end of May.

Well 4 and Romance Hill Generators are expected towards the end of August 2023.

Main Office Generator is currently expected to arrive March of 2024.

Well 6 Project

Well 6 Bid package is out and weare planning on a bid opening at 2 pm on April 11<sup>th</sup> 2023 directly prior to the 3 pm board meeting. Currently pursuing additional funding to make sure we can get this project as far as possible towards completion and connection to the system.

Also pursuing funding for possible reservoirs and building renovations or replacement and whatever infrastructure grants we can possibly get.

Waiting on the weather to stabilize.

## Overton and Associates

Currently discussing the district acquiring the property where our reservoir and wells are located, and possible future options for additional sites.

### Maintenance and Operations -

Jim Freeman reported on maintenance and operations (see attached list of topics)

Commissioner Satran-Loudin asked about the catch basin project: Bullseye Excavation installed the catch basin next door, had to come back and adjust the height of the grate (lower). We will be dressing out the outfall of the pipe and planting grass.

Commissioner Born asked if the pricing for the Rasor Road project is good, Freeman said it was a good price for the first phase of the project and is working with Webb to see about timing and feasibility to do the work. Discussed the project awarded to Zephyr for the lower shop grading and catch basin/storm installation. They will also be doing the work on the lower shop to shore up the roof and stabilize the sag in the roof. After trying for bids on that portion of the project for over 2 months they were the only bid received out of 4 contractors who looked at the job. There were 3 bids on the lot grading and installation of the storm basin and rerouting the storm line. Zephyrs was the low bid.

#### **New Business:**

WASWD meeting in April 12-14, who is wanting to attend. Both Commissioner Born and Commissioner Satran-Loudin will attend. Asked if Webb was planning on attending and Webb replied yes if at all possible. Webb will make the arrangements for rooms and conference. Since there is a bid opening on the 11<sup>th</sup>, we can leave the morning of the 12<sup>th</sup> as the conference does not start until 2 pm.
