7) Manager Update

Olympic Ridge, Olympic View development

Olympic View Apartments

Working thru the backflow assembly requirements for the apartments, we approved plans showing exterior pads and boxes for RPBAs and they wanted to put them inside the buildings and we will not allow that.

Olympic Ridge Homes

The house meters are awaiting sidewalk and curb to set the boxes, but while talking with the Fire Authority we discovered that the county was requiring the homes to be sprinkled which is the first we had heard of that. We have standards for that which the county and the developer/engineers all have. None of the standards for sprinklered homes were followed, it was not presented to us as a sprinkled project. We are working with the issues as they arise, ultimately not our thing but trying to be helpful.

CEDS Project Funding

Working on getting the current well 4 data together and sent, also requesting on our request for generator funding.

North Mason Fire Authority Project

Still waiting for payment on final billing as well as easement documentation then we can move to the resolution and finish.

Tom Burke says the contract is fine as is in terms of liability and he would do nothing further to add to it legally speaking. Which is understandable as it was written by Brian Snure and there is a huge difference in the way things were then and the way they are now as far as our relationship with the Fire Authority. I will be meeting with Beau in the near future and going over a couple possible modifications, possibly comping a minimum for power usage per month based on a base fee PUD with no power usage?
